THE FUSILIER COMPLEX, INC. – MATCH RULES AND REGULATIONS

The following rules and regulations shall be used for conducting all competitions and matches at the facilities and ranges of The Fusilier Complex, Inc.

- 1. The Match Director has ultimate responsibility for the safe conduct of all events.
- 2. The range being used to conduct the matches will NOT be available for use by members and their guests who are not participating in the matches.
 - a. The range being used to conduct the matches is for the exclusive use by the match participants
- 3. Reporting The Match Director shall report to Executive Board:
 - a. ANY Injuries sustained by anyone at the match from match activities.
 - i. Participants.
 - ii. Guests/Audience.
 - iii. Members on other sections of the range or nearby ranges.
 - iv. RSOs.
 - b. Results of the matches for publication in club communications.
- 4. Match Safety Rules must be presented and reviewed prior to the beginning of all matches.
 - a. Match safety rules are applied to all participants equally without exclusions (I.E. Match Director, RSO, Board Member, etc.).
 - b. Participants will be disqualified from the day's match for violating the following safety rules:
 - i. Sweeping allowing the muzzle to point at any part of the participant's body or other participants.
 - ii. violating the 180 degree muzzle rule. (While engaged in the course of fire, the participant's muzzle must not exceed 90 degrees of the median intercept of the impact berm. This does not include drawing from holster, attempting to re-holster a weapon, placing weapon or removing a weapon from a rack or case.
 - iii. loading a weapon or handling a loaded weapon prior to the match director's or RSO's command.
 - iv. negligent discharge.
 - v. any round discharged over the impact berm.
 - c. Participants may be subject to disqualification from a match participation for violating the following safety rules:
 - i. Finger in the trigger guard during reloading or clearing a malfunction, (trigger discipline).
 - ii. Pointing weapon over or away from impact berm while engaged in the course of fire.
 - iii. Other acts determined by both Match Director and RSO as unsafe for all other participants.
 - d. Match Director and RSO will have a defined and consistent set of commands for a course of fire. These commands include but not limited to:
 - i. Load and Make Ready / Make Ready
 - ii. Are you Ready / Is the Shooting Line Ready
 - iii. Standby
 - iv. Fire / Buzzer / Horn / Engage / ETC.

- v. Cease Fire / Buzzer / Horn / ETC.
- vi. Show Empty Chamber / Insert Chamber Flag
- vii Rack your Weapon / Holster your weapon
- viii. Line is Clear
- e. All other Range Safety Rules as defined by The Fusilier Complex Range Rules.
- 5. A Fusilier Complex RSO must be present at all matches.
 - a. Compensation of the RSO will be by agreement between the Match Director and the RSO.
 - b. The RSO cannot act as RSO while firing in the match.
 - i. The Match Director and/or another TFC RSO must act as RSO while the designated RSO is actually firing in a relay of the match.
 - c. Required number of RSOs in addition to the Match Director assisting with safety management.
 - i. 1 to 20 1 RSO
 - ii. 21 to 30 2 RSOs
 - iii. 31 To 40 3 RSOs
 - iv. Greater than 40 Special arrangement with the Executive Board
- 6. No minimum number of participants required.
 - a. EXCEPT for matches conducted on the rifle line A minimum of 10 shooters must participate in matches conducted on the rifle line, including the Match Director and RSO if they participate in the match.
- 7. Fees Match Director shall:
 - a. Collect a match fee from each participant.
 - i. The cost of the match fee is determined by the Match Director and shall be reasonable in nature.
 - b. Collect an additional \$10 fee from any match participant who is not a TFC member.
 - i. Family members who are not a registered member but reside with the registered member are exempt from paying the non-member fee.
 - ii. Any non-member fee shall be turned over to the Treasurer of The Fusilier Complex.
 - c. Within 5 business days, remit to the Treasurer of The Fusilier Complex the collected funds.
 - i. Check or money order Cash payments by mail to the treasurer are not accepted.
 - ii. Remit to: Treasurer The Fusilier Complex, 365 Moreau Rd, Arnaudville, LA 70512.
- 8. Range Use Agreement
 - a. All non-members and guests participating in match shall sign the standard Fusilier Complex Range Use Agreement.
 - b. The Match Director shall forward the signed Range Use Agreements to the Membership Secretary within 5 business days.
- 9. Rules and regulations governing the conduct of the matches are subject to change at the sole discretion of the Executive Board of The Fusilier Complex.
